On January 5, 2022, Governor Newsom issued Executive Order N-1-22. This Order supersedes the provisions in Executive Orders N-25-20, N-29-20, and N-08-21 pertaining to the Bagley-Keene Act and expands state bodies' ability to hold meetings entirely via remote-meeting technology through April 1, 2022.

The State Compensation Insurance Fund Board of Directors and its Committees are scheduled to meet on February 22-24, 2022 via telephone/video conference. The meetings will be held in public session via telephone/video conference, unless otherwise noted.
