V. EXECUTIVE SUMMARY:

It is a useful practice to construct a board agenda for the year ahead (annual calendar) indicating the substantive items to be addressed for each meeting, yet providing flexibility to consider other issues as they arise.

Part of the Board process is to set-up the annual calendar of agenda items for Board and Committee meetings, to be presented and approved at every November meeting.

Normally the four meetings are set for February, May, August and November with March/April placeholder for Board Continuing Education but there is flexibility to accommodate scheduling conflicts and for 2023 the first meeting is February.

VI. ANALYSIS:

The annual agenda provides a useful starting point to ensure that all the standing items and key issues will be covered throughout the year, and leaves room for ongoing changes and flexibility. Moreover, it indicates when each key topic is coming up for discussion, which can be used in the preparation of Board information.

As the year progresses, and the annual agenda is translated into a series of meeting agendas, the annual agenda should be reviewed and appropriate modifications should be made to ensure that the individual agendas are as useful as possible.

In 2021, the Board approved the following changes:

 Audit Committee Agenda – removed Special Investigation Unit (SIU) One-Way Communication Updates

- Governance Committee Agenda added Loss Prevention Strategic Plan Update. This is in response to the recommendation made at the February 2020 Board meeting to, at least for one year, have regular updates presented at the Governance Committee meetings, and have Governance oversee the Loss Prevention Strategic Plan during the transition. Governance Chair will then prepare a report out to the full Board as with other topics discussed during closed session.
- Board Agenda removed Loss Prevention Strategic Plan (see above justification)

For 2022 annual agendas, there were no recommended changes.

The staff has reviewed the Board and Committee agendas for 2023 and recommend the following changes:

- Audit Committee Agenda to note that Internal Audit now provides the Model Audit Rule (MAR) update, quarterly as part of their regular audit report.
- Investment and Risk Agenda removed CyberRisk update and critical vendors' list and added them under Security Plan Update, if applies. Added Annual Investment and Risk Committee Evaluation Effectiveness
- Governance Agenda the Governance, Compliance, and Privacy Update and Corporate Governance documents are now being sent as one-way communication, unless an action is required, it is added on the agenda.
- Board Agenda removed Financial update and combined with the President's report; removed 3-year Pre-Strategic Planning; Investment Portfolio Benchmark and Mgmt. of Investments and ERM Update, added the note "if applies, part of Investment and Risk Chair report out to the Board; Independent Auditor's report, added the note "part of Audit Chair report out to the Board".
